Jerry Pesick partner, Steinhardt Pesick & Cohen PC

erry Pesick was just a kid when he decided to become a lawyer. In those less-cynical times, he was certain the profession could make things better for people.

Now, as a partner with Southfield-based Steinhardt Pesick & Cohen PC, Pesick is convinced that his work does help people, especially those who battle government – either to build on their property or to protect their property from a government taking.

"Often people come to us in a survival mode," said Pesick, a specialist in eminent domain, land use, condemnation and property taxation.

Pesick was at the center of what is considered the largest eminent domain case in Michigan history: A Wayne County Circuit Court jury awarded his client, Detroit Plaza LP, a \$25 million verdict after the city of Detroit filed condemnation proceedings to take 6.3 vacant acres on the Detroit River as part of a proposed waterfront reclamation and casino project.


The city had offered only \$13.7 million for the land.

The 26-year legal veteran sees government's attitude growing more aggressive, particularly as local governments scramble to secure or prevent development.

"Some people who run for local elected positions have extreme views," he said. "Lots of boards are split. We are seeing a lot of bold stuff. They want a tremendous amount of control over projects.'

Most recently, Pesick and Cohen led the defense of a family trust as the City of Novi proposed to condemn land for a new road around the Novi Road/Grand River Avenue intersection.

"They can't use economic development as a reason for public purpose," he said. "The pure economic development argument is not going to be a satisfactory basis anymore."



After college, Pesick - who had an equal interest in government - went to work for Fred Steinhardt and Walter Mason, who were already known for their land use and property rights work.

The firm evolved, as did some of its focus on land use and eminent domain, and grew to more than 20 attorneys.

Pesick remained at the law firm until 2000. when he and the late Steinhardt decided to leave and form their own firm to continue practicing the specialties he loves most. The firm includes Pesick, Adam Cohen, Jason Long and David Nykanen.

"We wanted to get back to a smaller, boutique-type of firm," Pesick said.

INSIGHTS

Guiding principle: The clients' best interests come first and foremost.

Mentor: The late Frederick Steinhardt, my first employer and partner of 22 years.

How do you motivate people: Never ask them to do anything I either haven't done or wouldn't do myself. Being available to advise and offer encouragement with assignments.

Goal yet to be achieved: Effectuating needed change in Michigan law to better protect property owners in eminent domain proceedings.

Advice: Ability alone will not allow you to achieve success in the legal profession. Hard work and desire are equally, and probably more, important ingredients.
